GENERAL QUESTIONS:

1. When it comes to the acoustical ceilings what should rule, RCP A8.1 or Finish Schedule on A7.1?

Answer: A8.1. The intent is to replace any ceilings affected by the addition or remodeling.

2. On page A2.8 there is a 4" chase shown that is under the slab for water piping to run through to supply the Tilting Steam Kettle and the two Combo Oven Steamers. This chase has 5 tee's and a elbow turning up out of the slab at either end. Is there something else that is being supplied by this chase or can we install a chase as needed to supply the three units shown that need water? Our thought is to run one 3" chase to the Tilting Steamer to supply hot and cold. Then run one 2" chase to supply cold water to the Combo Oven Steamers and come up in between the two Combo Oven Steamers and put a tee to serve both units. Basically clean up the big chase pipe with all the tee's if they aren't needed.

Answer: Provide the chase as shown. These are allowances for future appliances. Refer to revised sheet P1.2.

3. I would also like to suggest running Pex piping through the underground chases because of its durability and it is more flexible than the copper, if that is acceptable?

Answer: No. Provide copper as shown. Refer to revised sheet P1.2.

4. On page P1.2 water piping is shown in the overhead to supply the two Combo oven Steamers and the Tilting Steam Kettle. I don't think this is correct as the is no wall to run the pipes in and a



chase is shown on page A2.8. Is that a correct assumption?

Answer: No, the water lines to the cooking line are to be run in the PVC chase under the slab as shown on A2.8, Kitchen Equipment Plan.

5. There is a P7 in the schedule, which is an exterior wall hydrant. None are shown on the drawings. Are there any, if so, how many and where are they going?

Answer: Refer to revised P1.2.

6. Item #21 Market Forge Hot Plate is no longer available and they have no substitute item. Please advise.

Answer: A different product has been selected and is included on revised sheet A2.8 and in revised specification section 11400.
